Woodcock-Johnson IV for Psychologists: Bridging Assessment and Intervention

This session will focus on the role of the WJ IV in comprehensive special education and psychological assessments. Topics will include interpretation of the W Score and Relative Proficiency Index, and use of the WJ IV Interpretation and Instructional Interventions Program (WIIP) to connect assessment results with intervention recommendations. Overview of the WJ IV Cognitive, Achievement, and Oral Language batteries will be included, as well as an introduction to the WJ IV Tests of Early Cognitive and Academic Development.
