The Flex *Non-Violent Crisis Intervention®* training delivery platform is a strategic blend of online and classroom learning to train more effectively. Once registered, participants receive online access to the course. **This portion must be completed before attending the classroom training.** An average participant can expect the online portion to take approximately two to three hours (some may spend less time and some may choose to spend more time).

The classroom session requires active physical participation. **Individuals MUST BE physically able to participate in all training activities.** Certification will not be given to those unable to participate. Please wear comfortable clothing and close-toed, flat heeled shoes or tennis shoes.
