Summary of Key Issues

Spectrum Central Coast opened for the 25/26 school year. Per the MOU outlined below, the SELPA has brought monthly enrollment and operational updates to SEOC, CBOs, and SELPA Governance, working towards data analysis that would support the approval of a funding model for 25/26, in alignment with the executed MOU.

On October 31, CBOs recommended, by majority vote, that the proposed funding model from May 2025 be approved for the 25/26 school year.

Summary of Previous Action

The SELPA Governance approved the contract with Spectrum Center, Inc. on April 11, 2025.

On June 13, 2025, the SELPA Governance Council approved the MOU that recognizes the partnership between the SELPA, Spectrum Center, Inc. Coast USD, and the K-12 LEAs within San Luis Obispo County SELPA in the establishment and operation of Spectrum Central Coast for the 2025-2026 school year.

The MOU outlines the (1) Effective date, (2) Fiscal responsibility, (3) Program referrals, (4) Attendance reporting and student transcripts, (5), Timeline for planning and review of any changes, (6) Term and termination, and (7) Legal language. Additionally, it included the following attachments:

- Program Agreement between Spectrum Centers, Inc. and SELPA
- Facility Agreement between Coast Unified School District and the SELPA
- NPS Funding Model Allocation
- Instructional Calendar and ESY for 25/26
- Individual Service Agreement
